*NOTE

There were 9 new memberships for the year. Annual dues for membership and insurance through Land Trust Alliance of BC is \$500. This is an essential expense given the benefits of membership of networking, education, connection with "experts" (lawyers, property assessors, experienced land conservancy personnel, biologists, etc.), option for shared insurance, publications and support.

Cost of the Ted Talks Through Trees campaign amounted to \$695.25, with some trees donated by PRT this year. We created 50 hardcopy newsletters to distribute with the trees and at our Seedy Saturday table, which were free because they were printed at home. Last year, the cost to print was \$164.63 and shows as promotion costs on this year's financial report as it was missed off last year's report. Tree campaign money donations came to \$1,247.00 which gives us a profit of \$551.75 for the event.

We attended the LTABC conference in Victoria, November 2023. Expenses were \$1,133.70. However, the attendees donated this full expense back to MLCS.

In March 2018 we opened a Power Saver account under our MLCS account to accumulate funds for Friends of Stillwater Bluffs. We received permission, from Canada Revenue, to accumulate up to \$3 million over the next 10 years for the eventual purchase of Stillwater Bluffs.

By the end of the 2023-24 year, \$16,619.01 was in the account, an increase of \$917.65 over last year.
